What data do we collect?

WL Risk Management collects the following data:

- Personal identification information (Name, email address, phone number, etc.)

How do we collect your data?

You directly provide WL Risk Management with most of the data. We collect data and process data when you:

- Register online or query our services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.

WL Risk Management may also receive your data indirectly from the following sources:

How will we use your data?

WL Risk Management collects your data so that we can:

- Process your information and manage your account.

How do we store your data?

WL Risk Management securely stores your data at WL Risk Management Head Office, 174 Dawes Road, Uxbridge, UB10 0RA. We keep all record on file with Authenticator app applied to all file access, as well as a hard copy safely secured.

Our company will keep your personal data for 12 months. Once this time period has expired, we will delete your data by permanently deleting all online files related, and shredding all hard copy files.

What are your data protection rights?

WL Risk Management would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that our company correct any information you believe is inaccurate. You also have the right to request to complete the information you believe is incomplete.

The right to erasure – You have the right to request that erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request to restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to our company’s processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that we transfer the data that we have collected to another organization, or directly to you, under certain conditions.
